This refers to the routine safeguards inspection conducted by W. Tobin of this office on August 31 to September 3, 1982, of activities authorized by NRC Licensee Nos. DPR-71 and DPR-62 at the Brunswick Steam Electric Generating Plant and to the discussions of our findings held with C. R. Dietz, Plant General Manager, at the conclusion of the inspection.

Areas examined during this inspection included your physical security program as implemented under the provisions of Title 10, Code of Federal Regulations, Part 73, "Physical Protection of Plants and Materials" and the specific requirements of your approved Security Plan. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, performance tests, and observations by the inspectors.

Within the scope of this inspection, no violations or deviations were disclosed.

One new Unresolved Item resulted from this inspection and is discussed in the enclosed report. This item will be examined during subsequent inspections.

We have examined actions you have taken with regard to previously reported unresolved matters. The status of these items is discussed in the enclosed report.






