This is in part 1 response to your letter dated January 4, 1983 in which you requested, pursuant to the Freedom of Information Act, access to copies of NRC inspection reports of safety violations noted at the Kerr-McGee plutonium plant at Cresant, Oklahoma from August 1972 to November 1972.
