SUMMARY: The U. S. Nuclear Regulatory Commission (NRC) staff plans to hold a public workshop for managers of the Organization of Agreement States. The Commission has directed the staff to review and prepare for the Commission's consideration recommendations to improve NRC's Agreement States Program to assure adequate protection of the public health and safety. In this process, the Commission staff has solicited the opinions of those with historical backgrounds in the Agreement State program and representatives of the Agreement States. Topics for discussion at the upcoming workshop include: Open Discussion of Agreement State Issues; New Policy Statement for NRC Agreement States Program; Integrated Materials Performance Evaluation Program; Sealed Source and Device Reviews; Federal Advisory Committee Act Update; Medical Management Plan; Allegations Received Against Radiation Control Frograms; National Data Base for Events Reporting; and OAS Task Force on National Events Data Base. A session on NRC Rulemakings will be held on the afternoon of July 12, 1994.
