Dear Mr. Stoeffler:

This is in response to your letter dated January 31, 1983, in which you requested, pursuant to the Freedom of Information Act, copies of medical misadministration reports from hospitals licensed in Wisconsin with regard to a November, 1982, report, "Report on Medical Misadministrations for January 1981 - June 1982", by the Office for Analysis and Evaluation of Operational Data.

The NRC began in January, 1982, to computerize pertinent data presented on hospital reports. As agreed during a telephone conversation between you and Linda Robinson on February 3, 1983, we are enclosing copies of the existing computer printout covering incidents reported during 1982, and subject hospital reports covering incidents occurring in 1981. These records are identified on the enclosed appendix.

Portions of the hospital records, identified at 1 through 25 on the enclosed appendix, have been deleted in order to withhold the names of and other identifying information regarding patients, physicians, and individuals directly involved in medical misadministrations. Because disclosure of this information would constitute a clearly unwarranted invasion of personal privacy, it is being withheld from public disclosure pursuant to Exemption (6) of the Freedom of Information Act (5 U.S.C. 552(b)(6), and 10 CFR 9.5(a)(6).

Pursuant to 10 CFR 9.9 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure, and that its production or disclosure is contrary to the public interest. The person responsible for this denial is the undersigned.

This denial may be appealed to the Commission's Executive Director for Operations within 30 days from the receipt of this letter. As provided in 10 CFR 9.11, any such appeal must be in writing, addressed to the Executive Director for Operations, U.S. Nuclear Regulatory Commission, Washington, DC 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision".
