Gentlemen:

This refers to the inspection conducted by Ms. C. Abigail Evans of this office during the period of January 10-14, 1983, of activities authorized by NRC Operating License DPR-40, and to the discussion of our findings with you and other members of your staff at the conclusion of the inspection.

The inspection related to your program and activities designed to protect against industrial sabotage and to safeguard special nuclear material. The inspection was based on the applicable provisions of Title 10, Part 50 of the Code of Federal Regulations entitled "Licensing and Utilization Facilities," within Part 73 entitled "Physical Protection of Plants and Materials," and the specific requirements of NRC Operating License DPR-40. Areas examined during the inspection and our findings are documented in the enclosed inspection report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector.

During this inspection, it was found that certain of your activities were in violation of NRC requirements. Consequently, you are required to respond to this violation, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material, with the exception of the report cover page, which is an inspection summary, will not be placed in the Public Document Room.

The response directed by this letter and the accompanying Notice is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
