3) Under Article I - Statement of Work last paragraph entitled Estimated Level of Effort, the level of effort for Project Director is hereby modified to read as follows:

"Project Director Approximately 30 staff days from the effective date of contract through December 31, 1982"

4) Article II - Period of Performance is hereby modified to read as follows:

"Article II - Period of Performance

The performance of work described in Article I herein shall commence as of the effective date of this contract and shall continue through December 31, 1982, at which time all work shall have been completed and all reports shall have been submitted."

In summary this Modification No. Three (3) modifies Article I and II of the contract as stated below:

- A. Article I Adds a new Task 3.
- B. Article I Changes the schedule for the Final Report.
- C. Article I Changes the level of effort for the Project Director
- D. Article II Extends the period of performance.

The above changes do not result in an increase to the total contract amount which remains unchanged at \$21,770.00.
