- II. Under Article I, Statement of Work, Section D. REPORTING REQUIREMENTS, paragraph No. 1 is deleted in its entirety and the following paragraph is substituted in lieu thereof:
 "A Draft TER covering the value-impact analysis shall be submitted within eight weeks of award to the Project Officer."
- III. Under Article I, Statement of Work, Section F. NRC Furnished Materials, add a revised No. 1, NRC Recommendations Concerning Steam Generator Tube Degradation and Rupture Events (draft) dated 7/12/82, and, add the following new

IV. Under Article III - Consideration and Payment, Section A. Estimated Cost, Fixed Fee and Obligation, delete Paragraphs 1 and 3 in their entirety and substitute the following in lieu thereof:

- "1. It is estimated that the total cost to the Government for full performance of this contract will be \$139,610.00 of which the sum \$128,082.00 represents the estimated reimbursable costs, and of which \$11,528.00 represents the fixed fee.
3. The amount presently obligated with respect to this contract is \$139,610.00"

V. Under Article X - Travel Reimbursement, Paragraph 1, delete the figure \$7,200.00 from the first sentence and insert "\$9,882.00" in lieu thereof.

All other terms and conditions of the contract remain unchanged. This modification results in an increase to the total contract amount by \$15,971.00 from \$123,639.00 to a new total of \$139,610.00.
