SUBJECT: NRC INSPECTION REPORT 030-02885/94-01

This refers to the routine, unannounced inspection conducted by Mr. Mark R. Shaffer of this office on February 3 and May 18-19, 1994. The inspection included a review of activities authorized by Byproduct Materials License 35-03176-01. At the conclusion of the inspection, the findings were discussed with members of your staff.

The inspection was an examination of activities conducted under the license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of the license. The inspection consisted of selective examinations of procedures and representative records, interviews of personnel, independent measurements, and observation of activities in progress.

No violations or deviations were identified; therefore, no response to this letter is required.

The inspector noted that you have maintained adequate management oversight of the radiation safety program during this inspection interval. The Radiation Safety Committee, through the Radiation Safety Officer, had continued to audit program activities at regular intervals. Based upon the inspector's observations, these audits have been effective in identifying and correcting program deficiencies. Those individuals using byproduct material had received appropriate training and appeared quite knowledgeable of proper radiation safety practices. Records of licensed activities were well organized and adequate for the size and scope of the program.


