SUBJECT: REPORT NOS. 50-269/83-01, 50-270/83-01, AND 50-287/83-01

This refers to the routine inspection conducted by A. Tillman of this office on January 10-14, 1983, of activities authorized by NRC License Nos. DPR-38, DPR-47, and DPR-55 at Oconee 1, 2, and 3 and to the discussions of our findings held with Mr. J. E. Smith, Station Manager, at the conclusion of the inspection.

Areas examined during this inspection included your physical security program as implemented under the provisions of Title 10, Code of Federal Regulations, Part 73, "Physical Protection of Plants and Materials", and the specific requirements of your approved Security Plan. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, performance tests, and observations by the inspector.

During the inspection, it was found that certain activities under your license appear to violate NRC requirements. This item and references to pertinent requirements are listed in the Notice of Violation enclosed herewith as Appendix A. Elements to be included in your response are delineated in Appendix A. Details of activities involving safeguards information are exempt from disclosure in accordance with 10 CFR 73.21. Therefore, your response should be incorporated in a separate paper and referenced in your reply.

We have examined actions you have taken with regard to previously identified enforcement matters. These are discussed in the enclosed inspection report.

One new unresolved item resulted from this inspection and is discussed in the enclosed report. This item will be examined during subsequent inspections.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material, with the exception of the report cover page which is an inspection summary, will not be placed in the Public Document Room.
