This refers to the routine safety inspection conducted by C. Rowe and Dr. M. McBride of this office on February 8-11, 1983, at Millstone Nuclear Power Station, of activities authorized by NRC License Nos. DPR-26 and DPR-65 and to the discussions of our findings held by C. Rowe and Dr. M. McBride with members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selected examinations of procedures and representative records, interviews with personnel, measurements made by the inspectors, and observations by the inspectors.

Our inspectors also verified the steps you have taken to correct the violations brought to your attention in the enclosure to our letter dated October 30, 1981. We have no further questions regarding your action at this time.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
