This refers to the inspection conducted by Mr. L. E. Martin of our staff during the periods of January 10-14 and January 24-28, 1983, of activities authorized by NRC Construction Permit C-PPR-103 for the Waterford Steam Electric Station, Unit 3, and to the discussion of our findings with Mr. L. L. Bass and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of the inspection, no violations or deviations were identified.

Three new unresolved items are identified in paragraphs 4a. and 4b. of the enclosed inspection report.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter, and submit written application to withhold information contained therein within 30 days of the date of this letter.
