SUBJECT: Grand Gulf Nuclear Station Unit 1 Docket No. 50-416 License No. NPF-13 File 0260/0840/L-860.0 Proposed Amendment to the Operating License (PCOL-83/03) AECM-83/0180

In accordance with the provisions of 10 CFR 50.59 and 10 CFR 50.90, Mississippi Power & Light Company (MP&L) requests an amendment to License NPF-13, for Grand Gulf Nuclear Station (GGNS) Unit 1. The requested amendment has two parts:

- Surveillance Procedure Review Package No. 1,
- Miscellaneous Technical Specification Changes.

In accordance with provisions of 10 CFR 50.30, three (3) signed originals and forty (40) copies of the requested amendment are enclosed. The attachment provides the complete technical justification and discussion to support the requested amendment. This amendment has been reviewed and accepted by the Plant Safety Review Committee (PSRC).

In accordance with the requirements of 10 CFR 170.22, we have determined the proposed amendment to be Class II.
