NOTICE OF NON-ROUTINE EVENT INVOLVING AGREEMENT STATE OR
AGREEMENT MATERIALS - 83-06

This Notice constitutes an early report of events occurring in an Agreement State of possible safety or public interest significance. The information presented is as initially received without verification or evaluation and is basically all that is known by State Agreements Program staff as of this date.

AGREEMENT STATE: New York

FACILITY: Long Island Nuclear Services
Bellport, New York
(former licensee)

SUBJECT: CONTAMINATION AT FORMERLY LICENSED SITE

Long Island Nuclear Services, Bellport, New York was formerly licensed by the New York Department of Labor and the AEC to collect radioactive waste from New York State and AEC licensees and ship the waste to licensed burial sites. The licenses were terminated in approximately 1970 because of recurrent noncompliance with the New York Department of Labor license. The licensee went bankrupt, and disposal of residual wastes at the licensee's facility was performed by Suffolk County, New York.

On February 28, 1983, at approximately 3 p.m., Region I was notified by the Suffolk County Department of Health that they were performing additional measurements at this formerly licensed facility, and had found indications of buried radioactive materials. The top of an unidentified object which they were attempting to excavate appeared to produce radiation levels of 4 mR/hr on contact. County inspectors are continuing to make measurements at this site, assisted by physicists from Brookhaven National Laboratories, Upton, New York.

Region I has notified the New York Department of Labor. No media interest has been reported. Region I will respond to press inquiries.

SUBJECT: COBALT-60 CONTAMINATION OF METALS PRODUCTION
FACILITY (Update)

This is to provide a further update on the contamination of the Auburn Steel Company steel plant in upstate New York.

On March 4, 1983, the company president and other management officials of the steel company met with EPA officials in Washington to discuss the Company's application for EPA Superfund monies to defray the cost of decontaminating the plant, estimated to at 1.2 million dollars. The decontamination project began March 3, 1983 and is likely to take 3 weeks. EPA officials expressed the view that this situation was not eligible for Superfund money. NRC-OSP representatives attended the meeting to address any questions concerning the Agreement State program and technical aspects of sealed source manufacture, distribution and use.

The steel company stated that scrap steel is obtained from about 100 sources in the northeast and in Canada. Scrap steel is usually processed within 10-14 days. IP has been notified of the possible international aspects. New York State Police are investigating the records of scrap shipments to the plant. Region I has furnished the State Police a list of companies authorized to manufacture or distribute Cobalt-60 sealed sources and a list of NRC licensees in New York authorized to possess Cobalt-60. The NRC Office of Investigation plans to offer the State Police assistance in their efforts to identify the origin of the Cobalt-60.

The New York Department of Labor has reviewed and approved a decontamination plan submitted by the contractor at the site. Region I has reviewed and commented on the plan.

Based upon available information, the contamination is confined to within the property boundaries of the steel plant and does not present an immediate threat to public health and safety. There is no evidence of contamination of workers.
