Subject: NRC Inspection

This refers to the routine safety inspection conducted by Mr. J. F. Pang of this office on September 14, 1982 of activities authorized by NRC License No. 50-17446-01 and to the discussion of our findings held by Mr. Pang with you at the conclusion of the inspection.

The inspection was an examination of the activities conducted under your license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of your license. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

During this inspection, it was found that certain of your activities appeared to be in noncompliance with NRC requirements. The items and references to the pertinent requirements are listed in Appendix A. These items have been categorized into severity levels as described in the NRC Enforcement Policy (10 CFR Part 2, Appendix C) 47 FR 9987 (March 9, 1982).

The findings from this inspection, as well as the one conducted during August 6, 1981 indicate a repetitive item of noncompliance (see Appendix A, Item C).

We are concerned about the repetitive nature of the item of noncompliance observed during our inspection. In addition to the need for corrective action regarding the specific item of noncompliance included in Appendix A, we are concerned about the implementation of your management control system that allowed this repetitive item of noncompliance to recur. Consequently, in your reply you should describe in particular those actions taken or planned to improve the effectiveness of your overall management control system.
