Subject: NRC Inspection of the Trojan Nuclear Plant

This refers to the routine, monthly inspection conducted by Mr. M. H. Malmros of this office during the period August 9 through September 3, 1982, of activities authorized by NRC License No. NPF-1, and to the discussion of our findings held by Mr. Malmros with Mr. Yundt and other members of your staff periodically during the inspection.

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A.

The item in the Notice of Violation has been identified as a Severity Level III violation, as defined in the NRC Enforcement Policy, 10 CFR Part 2, Appendix C. Severity Level III violations are usually subject to civil penalties. However, in view of the circumstances surrounding this violation, we have decided not to propose a civil penalty. The results of future inspections, including implementation of your corrective actions, will be considered in determining whether further enforcement action is appropriate.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
