At 0745 hours on 10/16/82 the licensee determined the unidentified RCS leakage to be 1.15 gpm. At 0800 hours an Unusual Event was declared. Over the next 21 hours, the licensee tried to identify the leakage, doing so at 0305 hours on 10/17/82 when the Unusual Event was terminated. The leakage was identified as leakage into the reactor coolant drain system through one or more RCS loop drain valves. The licensee will continue to monitor this leakage on a daily basis. With the identification of this leakage, the unidentified leakage now stands at 0.49 gpm.

This Preliminary Notification is issued for information only and no further action by Region V is anticipated.

Media interest is expected. The licensee issued a news release on 10/16/82. The NRC does not plan to issue a news release. Region V (San Francisco) received notificiation of this occurrence from the licensee at 0815 hours on 10/16/82. Region V activated its Incident Response Center on a standby basis from 0900 hours to 1300 hours on 10/16/82 in response to this event. The Senior Resident Inspector was dispatched to the site and was onsite from 1100 hours until 2100 hours on 10/16/82. This information is current as of 0900 hours on 10/18/82.
