SUBJECT: NOTICE OF VIOLATION (NRC INSPECTION REPORT NO. 50-293/94-09)

This refers to the safety inspection conducted by Messrs. J. Macdonald and D. Kern, of this office on April 5 to May 9, 1994 at the Pilgrim Nuclear Power Station, Plymouth, Massachusetts. Areas relevant to the health and safety of the public examined during this inspection are described in the enclosed report. Our findings were based upon observations of performance and independent evaluations of safety systems and quality records. The preliminary results have been discussed with Mr. W. Rothert and other members of your staff at the conclusion of the inspection.

Your detailed evaluation and resolution of degraded control rod scram times identified during a routine surveillance was outstanding. Although immediate corrective maintenance restored scram times to within required limits, you assigned an issue team to further assess scram time performance trends and component reliability. The issue team questioned the material reliability of the scram solenoid pilot valve diaphragms and recommended a reactor shutdown. The decision to shutdown the reactor and replace all scram solenoid pilot valve diaphragms demonstrated a clear safety perspective. Effective oversight of operations, engineering, and maintenance activities resulted in prompt restoration of scram time margins well below the required limits. Additionally, you actively coordinated with the vendor and communicated your findings to the industry to provide immediate notification of this potentially generic issue.

However, based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). Specifically, our inspectors identified two fire doors, one of which provides a safe shutdown separation barrier, that had been blocked open but had not been properly compensated by fire watches. Additionally, your staff identified several instances in which other fire doors had been disabled and a vehicle had been parked in the reactor building trucklock without proper fire watch compensation. The violation is of concern because it appears to have identified a weakness in your fire protection program as well as an apparent lack of sensitivity on the part of your staff to the importance of maintaining the integrity of fire barriers.
