Dear Mr. Opeka:

The U.S. Nuclear Regulatory Commission continues to become aware of concerns regarding maintenance activities at Millstone 1. Details are enclosed for your review and followup.

We request that the results of your review and disposition of these matters be submitted to Region I within 60 days of the date of this letter. We expect that your evaluation of these matters will be thorough, objective and of sufficient scope and depth to resolve these matters. We request that your response contain no personal privacy, proprietary, or safeguards information so it can be released to the public and placed in the NRC Public Document Room. If necessary, such information must be contained in a separate attachment, appropriately marked, which will be withheld from public disclosure. The affidavit required by 10 CFR 2.790(b) must accompany your response if proprietary information is included.

The Enclosure to this letter should be controlled and distribution limited to personnel with a "need to know." The Enclosure is considered Exempt from Public Disclosure in accordance with Title 10 Code of Federal Regulations, Part 2.790(a). However, a copy of this letter, excluding the Enclosure, will be placed in the NRC Public Document Room.

The response requested by this letter and the accompanying enclosure are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, Pub. L. 96-511.

Based on your findings and response in this matter, we will determine the NRC followup warranted in this matter. If you have any questions concerning this request, please contact P. Swetland at the resident office or L. Doerflein at (610) 337-5378. Your cooperation with us is appreciated.




