responses to Generic Letter 92-01, Revision 1, "Reactor Vessel Structural Integrity" as it pertains to the Haddam Neck Plant. The NRC Staff's letter of May 11, 1994, "indicated that CYAPCO has provided the information requested in Generic Letter 92-01, Revision 1 for the Haddam Neck Plant and requested CYAPCO to review the attachment to the May 11, 1994, letter for accuracy.

CYAPCO has reviewed the NRC Staff's May 11, 1994, letter and concludes that, in general, the information provided accurately reflects the information provided to the Staff, with the following exceptions.

In the summary file for pressurized thermal shock, there is a typographical error for the I.D. neutron fluence at End of Life (EOL) for the lower shell plates (W9807-3, -5, and -7) and the lower circumferential weld. The I.D. neutron fluence at EOL incorrectly reads 4.03E18 n/cm². The I.D. neutron fluence at EOL should read 4.03E19 n/cm². This does not impact the evaluations performed under Generic Letter 92-01, Revision 1, since the correct fluence values were used for these evaluations.

In the summary file for upper shelf energy, the 1/4t Upper Shelf Energy (USE) at EOL for the nozzle shell plates (W9807-1, -6, & -8) reads 81, 50, and 68 ft-lb respectively. Based on CYAPCO'S January 15, 1993, letter CYAPCO believes that the 1/4t USE at EOL for nozzle shell plates W9807-1, W9807-6, and W9807-8 should be 86.1, 52.9, and 73.8 ft-lb respectively.
