Gentlemen:

This refers to the inspection conducted by Mr. C. J. Hale of this office on August 17-18, 1982, of your facility at Lynchburg, Virginia, and to the discussions of our findings with you and members of your staff at the conclusion of the inspection.

This inspection was made in response to a request from the NRC's Division of Systems Integration (DSI) to inspect the development, verification, and use of computer codes, POWER TRAIN, CADDS, and TRAP-2. The results of this inspection will be provided to DSI for input to the Safety Evaluation Report they are preparing for these codes.

Areas examined and our findings are discussed in the enclosed report. Within these areas, the inspection consisted of an examination of procedures and representative records, interviews with personnel, and observations by the inspector.

During the inspection it was found that the implementation of your QA program failed to meet certain NRC requirements. The specific findings and references to the pertinent requirements are identified in the enclosures to this letter.

Please provide us within 30 days from the date of this letter a written statement containing: (1) a description of steps that have been or will be taken to correct these items; (2) a description of steps that have been or will be taken to prevent recurrence; and (3) the dates your corrective actions and preventive measures were or will be completed. Consideration may be given to extending your response time for a good cause shown.

The response requested by this letter is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
