WCAP-13360, "WESTINGHOUSE DYNAMIC ROD WORTH MEASUREMENT TECHNIQUE"
(TACS M84164 AND M84165)

By letter dated July 10, 1992, you confirmed your desire to utilize the technique described in WCAP-13360 to evaluate rod worth during startups following refueling outages. This WCAP had previously been submitted by Westinghouse to the staff for review, a topical report review TAC number had been opened, but the review had not been initiated. Upon receipt of your letter, unit-specific TAC numbers were opened for Point Beach, and a work request was submitted to the Reactor Systems Branch requesting evaluation of the WCAP.

Due to the low safety significance of this issue, the review has been delayed. It is currently scheduled to begin this fall. In addition, since the review will be completed under the topical report TAC number, there is no need for unit-specific TAC numbers. Therefore, TACs M84164 and M84165 are being closed.
