Gentlemen:

Effective January 1, 1983, AT&T Long Lines and Bell Operating Companies (BOC) are prohibited from furnishing new customer premises equipment (CPE) or new additions to existing CPE if required equipment is not in inventory. This decision (Section 64.702 of FCC Rules and Regulations) is causing a severe impact on our ability to install/move/rearrange most ENS and HPN service.

On January 5, 1983, AT&T filed with FCC a Petition for Waiver of Section 64.702 of FCC Rules and Regulations. The Department of Defense has filed a statement in support of the Petition for Waiver and NRC has filed with DOD a similar supporting statement. In addition, due to the build-up of delayed service orders, the FCC was requested to provide the NRC with immediate relief by granting an interim waiver, permitting AT&T Long Lines and Bell Operating Companies to furnish CPE for nuclear power plants, as outlined in the AT&T Petition for Waiver.

In the meantime, you should continue submitting requests for ENS/HPN service through the Region III Office to the Headquarters Telecommunications Branch. Orders will be processed only for moves of existing ENS/HPN service within the same building. Should immediate phone service be required, contact this office and an order will be placed for local commercial telephone service. This will provide an interim communications capability until these problems are resolved.


