Gentlemen:

This refers to the QA program inspection conducted by Mr. R. E. Oller of this office on September 14-16, 1982, of your facility at Foxboro, Massachusetts, and to the discussions of our findings with you and members of the plant staff at the conclusion of the inspection.

This inspection was made to confirm that, in the areas inspected, you. A program is being effectively implemented. The inspection effort is not designed to assure that unique quality requirements imposed by a customer are being achieved; nor to assure that a specific product, component, or service provided by you to your customers is of acceptable quality. As you know, the NRC requires each of its licensees to assume fuil responsibility for the quality of specific products, components, or services procured from others. You should, therefore, not conclude that the NRC's inspection exempts you from inspections by an NRC licensee or his agents, nor from taking effective cerrective action in response to their findings.

Areas examined during the inspection and our findings are discussed in the enclosed report. Within these areas, the inspection consisted of an examination of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, we found no instance where you failed to meet NRC requirements.
