This report transmits the findings of the safety inspection conducted by the resident inspectors at the Calvert Cliffs Nuclear Power Plant. At the conclusion of the inspection, these findings were discussed with Mr. Cruse of your staff.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter and were selected in order to ensure that your facility is operated with due regard for the public health and safety. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors. Overall, the NRC has concluded that your facility was operated in a safe manner.

Your completion of the Unit 1 refueling outage safely with no events caused by personnel error was noteworthy and indicative of a good shutdown safety program. Operators performed well during several plant manipulations required by equipment problems on Unit 1 and a scheduled short outage on Unit 2.
