SUBJECT: HADDAM NECK INSPECTION 94-12

This letter refers to the inspection conducted by Mr. Brian J. McDermott of this office between May 9 - 13, 1994, at the Haddam Neck Nuclear Power Station. The purpose of this inspection was to evaluate your corrective actions in response to previous findings; specifically, work control and valve issues. This inspection also addressed residual heat removal heat exchanger capacity and high pressure safety injection (HPSI) inservice testing. At the conclusion of the onsite inspection, the preliminary results were discussed with Mr. John D. Haseltine and other members of your staff.

In general, the inspector found your corrective actions acceptable. Improvements were noted in the quality of work package documentation and in the area of work preparation/control using the Integrated Team approach. The motor-operated valve (MOV) issues were satisfactorily addressed through revision of the program manual.

No response to this letter is required, and your cooperation with us in this matter is appreciated.
