MEMORANDUM AND ORDER CORRECTING LILCO
EXHIBIT NUMBERS INDEXED IN TRANSCRIPT
OF APRIL 8, 1983


There are errors in the assignment of LILCO exhibit numbers in the transcript of April 8, 1983, which should be noted by the parties. It appears that the court reporter erroneously assigned LILCO Exhibit No. 73 to the OQA staffing agreement^{1/} bound in ff. Tr. 21,000. It purposefully was not assigned an exhibit number by the Board. This error has caused the subsequent two LILCO exhibits indexed (Tr. 20,997) to be misnumbered. More seriously, it has caused the last LILCO exhibit marked for identification to be neither listed in the index list

(Tr. 20,997), nor bound-in as directed, and for there to be overlap and inconsistencies in the exhibit numbers appearing at the points in the transcript where the last two LILCO exhibits were identified.

At this point, it appears to the Board that the least complicated correction is to allow the LILCO exhibit numbers to remain as they appear in the transcript index (Tr. 20,997), particularly since the reporter attempted to use these numbers later in the transcript where the exhibits are identified. The missing LILCO exhibit is hereby identified as LILCO Exhibit 76. It is a memorandum dated March 30, 1983, from W. H. D'Ardenne to G. L. Wessman, consisting of one page and two pages of attachments. It was identified at Tr. 21,165, and rejected at Tr. 21,165-69. Since this exhibit was not bound in as it should have been (ff. Tr. 21,169), the Board is attaching one of its copies to this memorandum for the convenience of the parties.

AD HOC COMMITTEE ON IMPORTANT TO SAFETY RECOMMENDATION

The current practice utilizing two major classifications, safety related and nonsafety related, for design, construction, testing and operation of nuclear power plants is acceptable and appropriate. This has occurred with a general understanding and usage that the terms "Important to Safety" and "Safety Related" are equivalent in meaning. The current practice has recognized that within the nonsafety related set, there are varying degrees of importance to safe and reliable operation. For many or most items of this nature, standards have been promulgated to guide design, construction, testing and operation.

Even so, the NRC may determine there is a need, for licensing purposes, to identify a category of items, although nonsafety related, are of more importance to the safe and reliable operation of the plant than other nonsafety related items. If so, the term "Important to Safety" should not be used to designate this set of items because of the past history of equivalence to the term "Safety Related". To apply the term, "Important to Safety" across the body of regulations to a new set of items would cause the term to become unclear as to the meaning of all current regulations and licensing commitments that stem therefrom.

If this set of items is defined, it should be on a functional basis (e.g., ANS-51.1 and ANS-52.1). Requirements in existing standards for such functions, that are unique to specific functions, should be used.
