Dear Mrs. Ellis:

This is to confirm our telephone conversations of April 14, 1983, and April 25, 1983 concerning your discovery requests of the NRC Staff. In our telephone conversation of April 14, 1983, we discussed "CASE's Request to NRC Staff for Admissions," which you informally transmitted to us to see if we could "reach stipulations on some of them" (CASE's letter to me of March 21, 1983). Also see Transcript of Telephone Conference Call, April 7, 1983, at Tr. 104-105. As I stated during our phone conversation, the Staff stipulates to the following statements in CASE's request for admissions:
