This letter transmits the report of the resident safety inspection conducted by Messrs. L. Briggs and S. Pindale for the period April 19, 1994, through May 30, 1994, at the Oyster Creek Nuclear Generating Station. The inspection consisted of document reviews, personnel interviews and observation of activities. The inspectors discussed the findings with you and members of your staff after the inspection. Inspector observations during this report period indicate that overall plant operations were conducted safely.

Based on the results of this inspection, certain of your activities related to proper anchoring and storing of loose equipment throughout the plant appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation. You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. The response directed by this letter and the enclosed Notice is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, Public Law No. 96.511.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.
