Subject: NEWS MEDIA INTERVIEW OF REGION V MANAGEMENT PERSONNEL REGARDING ACTIVITIES AT RANCHO SECO

On February 2, 1981, Mr. Tom Duhain, a news reporter from KCRA-TV Channel 3, a Sacramento Television Station, met with Region V Management personnel for the purpose of conducting interviews regarding various allegations and concerns that had been provided to Mr. Duhain by current and former Rancho Seco employees. The various concerns and allegations involved loss of personnel (licensed and nonlicensed), possible poor management, and possible acts of sabotage.

The specific items that had been identified to Mr. Duhain, by the current and former Rancho Seco employees, and discussed at the interview, had been previously identified to the NRC and had been previously evaluated by the NRC Region V.

The interviews of Region V personnel along with the associated interviews of SMUD and State of California Energy Commission personnel will be aired on KCRA-TV Channel 3 from 8:00 PM to 9:00 PM (PST) on February 3, 1981.
