This letter refers to the safety inspection conducted by Ms. Laurie Peluso of this office on May 23 - 27, 1994, of activities authorized by NRC License No. DPR-61 at the Haddam Neck Station, East Haddam, Connecticut, and to the discussions of our findings held by Ms. Peluso with Mr. Nevelos and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection, involving your radioactive liquid and gaseous effluent control programs, are important to public health and safety and are described in the NRC Region I Inspection Report that is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, we noted that implementation of the radioactive liquid and gaseous effluent control programs continued to be very good. Your calibration technique for the radiological calibrations of the effluent radiation monitoring systems was noteworthy. Also noteworthy was your initiative to upgrade certain effluent/process radiation monitoring systems. No safety concerns or violations of regulatory requirements were identified.

No response to this letter is required. Your cooperation with us in this matter is appreciated.
