The Office of Nuclear Regulatory Research is planning a session on Severe Accident Research during its 22nd Water Reactor Safety Information Meeting on October 24-26, 1994, at the Bethesda Marriott Hotel, Bethesda, Maryland. You are invited to present a paper on MELCOR code development and validation to be given in the morning of Monday, October 24, 1994. The text of the full paper must be received by Ms. Monteleone by October 24, 1994, to be included in the Proceeding of the meeting. Notify me if you cannot participate in the meeting or if you have any problems with the scheduling of your presentation or with the preparation of the written material.

I look forward to your presentation and to seeing you at the October meeting.
