SUBJECT: DISTRIBUTION OF TRITIATED WATCHES

This refers to the telephone discussion between Mr. Don Galliers of your staff and myself and others of my staff on June 13, 1986, concerning the lifting of restrictions described in our Confirmatory Action Letter (CAL) No. 86-09 to you dated June 12, 1986.

Based on information provided by Mr. Gailiers during the June 13 telephone discussion, I agreed that shipments of Swatch Watches could be resumed under the following conditions:

- a. That you furnish this office with an affidavit from the manufacturer of the watches showing that all watches have passed the quality assurance tests required by the NRC license.
- b. That, pending our receipt of the affidavit described above and my confirmation to you or Mr. Galliers that the affidavit provided the required information, you will maintain records of the destination of all shipments of Swatch Watches.
- c. That, if you fail to demonstrate that the NRC license conditions have been met, you would recall all shipments of watches made between June 13, 1986, and the date of my notification to you.

The certificate that the required quality assurance tests had been successfully performed was received by this office on June 16, 1986. Accordingly, all conditions agreed to in the CAL have been met or rescinded as moot.

This also confirms receipt of the sample Swatch Watch containing tritium. We have completed our examination of the watch and, as previously agreed in the CAL, this watch is being returned to you, under separate cover.


