This letter refers to the Enforcement Conference held at the NRC Regional Office in King of Prussia, Pennsylvania, on July 13, 1989, relating to activities conducted under your NRC license. The meeting was attended by Edward A. Adelberg and George Holeman of your staff and Thomas T. Martin, Deputy Regional Administrator and other members of the NRC staff. It is our view that this meeting was beneficial and improved our understanding of your actions and allowed us to express our concerns regarding operation of your Radiation Safety Program and the violations identified in the recent inspection. The subjects discussed at this meeting are included in the enclosed Enforcement Conference Report. A subsequent telephone conversation between Mr. Holeman and Mr. John Kinneman of this office is also documented.
