12. DESCRIPTION OF AMENDMENT/MODIFICATION

Pursuant to Clause No. 34 of the General Provisions entitled "Negotiated Overhead Rates," the following modification is made:

ARTICLE IV - ALLOWABLE COST/COMPENSATION, Paragraph A, Indirect Costs, is amended to read as follows:

"1. The contractor shall be reimbursed for engineering overhead at final rates of 138.61% and 143.83% for the contractor's fiscal years 1978 and 1979, respectively, and applied to a base composed of direct engineering labor dollars.

2. The contractor shall be reimbursed for General and Administrative (G&A) expenses at final rates of 13.51% and 12.16% for the contractor's fiscal years 1978 and 1979, respectively, and applied to a base composed of total costs less G&A expenses."

c. This modification also deobligates the unliquidated balance of \$354.67 remaining in the contract. As a result of this modification the total amount obligated by the contract is decreased from \$28,974.00 to \$28,619.33.

Except as provided herein, all terms and conditions of the document referenced in block 8, as heretofore changed, remain unchanged and in full force and effect.
