NOTIFICATION OF SIGNIFICANT ENFORCEMENT ACTION

Licensee: Kelli J. Hinds (IA 94-012)

Subject: ORDER PROHIBITING INVOLVEMENT IN NRC LICENSED ACTIVITIES
(EFFECTIVE IMMEDIATELY)

This is to inform the Commission that an Order Prohibiting Involvement in NRC Licensed Activities (Effective Immediately) was issued May 23, 1994 to Kelli J. Hinds. The action was based on an inspection and investigation which concluded that she: (1) intentionally increased the dosage level of NRC-licensed materials given to patients without obtaining authorization from a physician authorized user, and (2) falsified the dosage measurement records associated with those administrations so that the dosage increases could not be determined from a review of the records. The Order removes Ms. Hinds from NRC-licensed activities for a period of one year from the date of the Order and requires, for an additional three year period from the date of the Order, that Ms. Hinds: 1) provide a copy of the Order to any prospective employer who engages in NRC-licensed activities at the time she solicits or begins negotiating employment with the prospective employer; and 2) provide notice to the Director, OE within 20 days of her acceptance of an employment offer involving NRC-licensed activities, or her becoming involved in NRC-licensed activities. The staff consulted with the Commission on this action in SECY-94-103, and the Commission approved the issuance of the action by SRM dated May 20, 1994.

Ms. Hinds or any affected person may request a hearing within twenty days of the date of the Order.
