CLOSURE OF ACTION ITEMS FROM MARCH 16, 1994 MEETING OF THE

NEW YORK STATE COMMITTEE ON LICENSING

The New York staff identified four action items per the April 5, 1994 memorandum to files for OSP/Regional staff to provide information back to the various State agencies from the March 16, 1994 meeting. The four items have been resolved as follows:

1. Provide an update for R. Aldrich and D. Ross on the Proposed changes to the sewer limits. (action - K Schneider)

Provided an update from C. Trottier, RES. Called R. Aldrich and D. Ross on 4/11 & 4/12 with information - item closed.

Status of the availability of the sealed source directory on 2. diskette. (action - K. Schneider)

Informed R. Aldrich and D. Ross on 4/11 & 4/12 that the diskettes would not be ready till later summer and that information would be in the monthly SS&D newsletter - item closed.

3. Status of the NYDOL letter regarding financial assurances. (action - k. Schneider)

On 4/13 informed R. Aldrich letter was being handled by S. Droggitis.

4. Information as to how NRC reviews are handling the financial reviews for their licensees. (action - C. Gordon)

C. Gordon talked to R. Aldrich regarding sample cases. During his discussion, R. Aldrich indicated that her agency was not interested in the sample case, but in obtaining a list of consultants to perform the financial reviews for the State. He asked R. Aldrich to check with the other New York programs to determine if assistance was available. She indicated that she had attempted to do so, however, was unable to obtain assistance from them. Per C. Gordon's discussion with the State, he indicated
