## COMMENTS ON DRAFT RULES

## Maryland Standards for Protection Against Radiation

Definition

Comment

ALARA

Use the SSR or CFR definition for this term.

Declared pregnant woman

Add the provision for the woman to give her estimated date of conception so the calculations in D.208 may be made.

Effective dose equivalent

There is a typographical error in the formula,  $W_t$  should be  $W_{\tau}$ .

Exposure

Delete the sentence "For purposes of these regulations, this term is used as a verb."

High radiation area

The definition specifies that rooms in which diagnostic X-ray systems are used are not considered high radiation areas. This should be changed to specify that the rooms are considered to be high radiation areas, but are exempted from the posting requirements of the rules. The other safety standards for high radiation areas should apply.

Member of the public

In the second sentence, change the words "... enters a restricted area ..." to read "... in which the individual receives an occupational dose ..." It is possible for a member of the public to enter a restricted area and not receive an occupational dose.

Occupational dose

Delete the words "... in a restricted area or ..." It is possible for an individual to enter a restricted area and not receive an occupational dose.

Public dose

After the words "... from exposure to ..." add "... radiation and to radioactive material released by the licensee or registrant, or exposure to ..." before the words "... sources of radiation." Delete the word "either."

Weighting factor w,

The term is defined in both Part A and Part D of the Maryland rules. The definitions are the same, but one of them should be deleted.

D.206c	10 CFR 1206 - Add the following (underlined) text: "The licensee or registrant, and employer if the employer is not the licensee or registrant specifically authorizes the planned special exposure, in writing, before the exposure occurs."
D.301a	10 CFR 20.1301 - Add the provision: "c. If the licensee or registrant permits members of the public to have access to restricted areas, the limits for members of the public continue to apply to those individuals."
D.302b.i	10 CFR 20.1302 - The requirement to comply with the ALARA provision in §D.101a is not consistent with the other requirements of this rule. That requirement should be moved to another rule.
D.906b.i	10 CFR 20.1906 - Change "A.Z" to read "A.Z"
D.906b.ii	10 CFR 20.1906 - The added text appears to be redundant to paragraph b.i
D.906b.iii	10 CFR 20.1906 - Change " the package has evidence of potential contamination" to read " there is evidence of degradation of package integrity."
D.1001d.iv	10 CFR 20.2001 - Add the underlined: "Disposal, or storage until transferred to a disposal facility authorized to receive the waste."
Appendix B	Several typos noted, we recommend conducting a careful, two-person check of the table entry by entry against appendix B of 10 CFR Part 20.
Appendix F	A copy of this appendix was not submitted. The provisions must be adopted, unless included elsewhere in the rules.
D.1209a.ii	10 CFR 35.33 - Add "actions taken to prevent recurrence" to the list of items to appear in the report.
