SUBJECT: NRC REQUEST FOR INFORMATION REGARDING LICENSED
OPERATOR APPLICATION MATERIALS

On March 23, 1994, PSE&G provided preliminary information to our office that an individual, who previously held a Senior Reactor Operator license at the Hope Creek Generating Station, had provided false information in the license application regarding education background. Subsequently, PSE&G conducted an investigation to review the circumstances surrounding this occurrence and identify corrective measures to prevent recurrence. The event was reported on April 14, 1994, as Licensee Event Report 94-002-00 in accordance with 10 CFR 50.73.

In order for the NRC to complete its review of this matter, we request that you provide a copy of your investigation results to the NRC Region I Office within 30 days of receipt of this letter. Your response should not, to the extent possible, include any personal privacy, proprietary, or safeguards information so that it can be released to the public and placed in the NRC Public Document Room. If personal privacy information is necessary to provide an acceptable response, then please provide a bracketed copy of your response that identifies the personal privacy-related information and a redacted copy of your response that deletes the personal privacy-related information. Identify the particular portions of the response in question which, if disclosed, would create an unwarranted invasion of personal privacy, identify the individual whose privacy would be invaded in each instance, describe the nature of the privacy invasion, and indicate why, considering the public interest in the matter, the invasion of privacy is unwarranted. If you request withholding on any other grounds, you must specifically identify the portions of your response that you seek to have withheld and provide in detail the bases for your claim of withholding (e.g., provide the information required by 10 CFR 2.790(b) to support a request for withholding confidential commercial or financial information).


