SUBJECT: ROUTINE INSPECTION NOS. 030-30685/94-001 AND 030-30290/94-001

On April 12, 1994, Betsy Ullrich of this office conducted a routine safety inspection at 20 East Halsey Road, Parsippany, New Jersey of activities authorized by the above listed NRC licenses. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. The findings of the inspection were discussed with Eileen Bauman, National Parts Operations Manager, at the conclusion of the inspection. This also refers to the telephone conversations during March, 1994, between you and Sharon Johnson and David Everhart of our staff.

Because License No. 04-23699-01 expired November 30, 1993, you do not have a current authorization to possess licensed material. We understand that as of April 12, 1994, the Toshiba America, Inc. facility in Parsippany possesses a total of 68 main frame units and 15 lamps containing licensed material in storage, and that you plan to transfer these parts to your facility in California. We further understand that you no longer market the machines which contain licensed material and have not received licensed material for approximately 5 years. If you plan to terminate your license for possession in the State of New Jersey, a completed Form 314 "Certificate of Disposition of Materials" (enclosed) must be submitted to the NRC Region I office with your request to terminate License No. 04-23699-01. A letter requesting termination of License No. 04-23699-02E should be sent to the NRC, Office of Nuclear Material Safety and Safeguards, Washington, DC 20555 if you also wish to terminate that license.
