SUBJECT: UPDATE OF ROUTINE INSPECTION NO. 030-12270/92-001

On April 30 and May 1, 1992, Mrs. Teresa Hall Darden of this office conducted a routine safety inspection at the above address of activities authorized by the above listed NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. The findings of the inspection were discussed with Mr. Clarence J. Silvia and other members of your staff at the conclusion of the inspection.

In our letter to you dated June 2, 1992, we stated that "the issues identified during the inspection as apparent violations pertaining to the Radiation Safety Committee and the Radiation Safety Officer would be the subject of future correspondence pending further NRC review of these matters". We have concluded our review and evaluation, and our findings are identified in Appendix A, Notice of Violation.

Based on the results of this inspection, it appears that your activities were not conducted in full compliance with NRC requirements. A Notice of Violation is enclosed as Appendix A and categorizes each violation by severity level in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions," 10 CFR Part 2, Appendix C (Enforcement Policy). You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

Please use the enclosed self-addressed green envelope when you submit your copy to the Regional Administrator, Region I. This will assist us in the timely processing of your response. In accordance with Section 2.790 of NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and your reply will be placed in the Public
