This letter is to address the single violation noted during the referenced inspection. The following information follows the outline for the response requested in your letter.

1. Reason

At the time of the January 12-13, 1994 inspection, the Radiation Safety Committee was considering two versions of a Radiation Safety Program document covering the entire program, one brief version and the other more detailed. The final document had not been adopted or forwarded for approval by the Provost. However, all elements of the program were already documented in separate documents that had been approved.

2. Corrective Steps Taken

The Radiation Safety Committee at its meeting on January 24, 1994, approved the detailed version of the document and forwarded it to the Provost for approval. The document has since been approved. A copy is on file in the Radiation Safety Section.

3. Corrective steps to be taken

None called for at this time.
