SUBJECT: NRC INSPECTION REPORT NO. 70-824/94-02

Thank you for your response of May 20, 1994, to our Notice of Violation issued on April 22, 1994, concerning activities conducted at your Lynchburg Technology Center facility.

In your response you denied the violation and requested that it be withdrawn. After careful consideration of the basis for your denial, we agree with your analysis that the root cause of the shipment not being delivered to your facility was that the paperwork shown to the B&W security personnel at the time of arrival of the shipment was improperly addressed to another licensee and that the B&W security personnel would not have been required to exercise the notification call list.

We are still concerned that shipments of this type can arrive at your site during nonworking hours and the B&W security personnel responsible to direct it to the proper location and provide notice to you, may not be aware of its pending arrival. This appears to be a weakness in your internal notification system which should be addressed.

The violation is withdrawn and our records have been changed to reflect this.

We appreciate your cooperation in this matter.
