

RESPONSE OF ENERGY FUELS NUCLEAR, INC. TO THE REQUESTS FOR HEARING FILED BY NORMAN BEGAY AND BY DOWNWINDERS, INC.

Energy Fuels Nuclear, Inc. (EFN), by its undersigned attorneys and pursuant to 10 C.F.R. § 2.1205(f), submits this memorandum in response to the respective hearing requests filed by Norman Begay and by Steve Erickson for Downwinders, Inc. (Downwinders).

## 1. Request of Norman Begay.

with NRC Staff Counsel's response dated June 10, 1994, concerning the deficiencies of Mr. Begay's request. EFN does not, however, object to Mr. Begay's request, with the understanding that Mr. Begay's request is made on his own behalf, and not on behalf of any other person, and that Mr. Begay will be required to provide additional information in support of his request, specifically including the location

of and the completion data on the domestic well referred to in Paragraph 5 of his request dated May 14, 1994.

# 2. Request of Downwinders, Inc.

EFN also concurs with the recommendation of Staff Counsel that Mr. Erickson's request on behalf of Downwinders be denied for failure to meet any of the requirements of 10 C.F.R. § 2.1205(d).

An additional fact concerning this request should be brought to the Presiding Officer's attention. EFN is informed and believes that Mr. Erickson has misrepresented certain facts in his hearing request on behalf of Downwinders. A routine inquiry by EFN into the corporate status of Downwinders has revealed that Downwinders was involuntarily dissolved during 1991 by the Utah Division of Corporations. A copy of the Division's report confirming the status of Downwinders is hereto attached as Exhibit A. The information provided by the Utah Division of Corporations is directly contrary to the representations made by Mr. Erickson on behalf of Downwinders, and the affirmative misrepresentations in that hearing request should serve as an additional basis for denial.
