Subject: Perry Nuclear Power Plant Safety Evaluation Report (SER)
 Confirmatory Issue (7) - TMI Action Plan Item II.K.3.18
 Requirements

This is to advise that the NRC staff has received the BWR Owners Group proposed options for modifying the initiation of the Automatic Depressurization System for meeting TMI II.K.3.18 requirements. As you are aware, the modifications involve several design options for ATWS mitigation and on the execution of procedures developed from the BWR Emergency Procedure Guidelines. From a preliminary review of the BWR Owners Group proposal (letter from T. J. Dente to D. Eisenhut dated October 28, 1982) the staff has advised the project manager (J. J. Stefano) that additional information will be required from the Group to complete its generic review of the proposed modification option.

Accordingly, CEI is encouraged to formally endorse the modification chosen for Perry in order that the staff may promptly address the Perry modification upon completion of its generic review of the Groups' submittals. Until this is done, the staff will not be able to act on resolving SER Confirmatory Issue (7).
