12. DESCRIPTION OF AMENDMENT/MODIFICATION

This modification confirms the agreement reached by telephone conversation of October 29, 1982 between Mr. J. Martin Jones of Press Intelligence, Inc. and Mr. Arnold Gildenhorn of NRC. Accordingly, the above numbered contract is modified as set forth below:

- Article II, Period of Performance, is deleted in its entirety. The following is substituted in lieu thereof:
"The period of performance shall commence on November 1, 1980 and extend through November 7, 1982."
- Work performed during the period from the effective date of this modification through the conclusion of the period of performance as modified above shall be billed at the Unit Prices set forth in Article I, lines 3, 3A, 4, and 4A. The monthly reading fees (lines 3A and 4A) shall be billed at a prorated amount for the period of performance extended herein. Thus, for the period of 11/1/82 through 11/7/82, the contractor shall bill for \$200.00 for line # 3A, and \$22.50 for line 4A.
- The above changes are accomplished without any increase in the total amount of this contract.

Except as provided herein, all terms and conditions of the document referenced in block 8, as heretofore changed, remain unchanged and in full force and effect.
