Dear Mr. Russell:

Reference 1 letter transmitted Commonwealth Edison Company's (CECo) request for an Emergency Technical Specification amendment to Section 3/4.4.5. This amendment request was subsequently granted and transmitted in Reference 2. In that April 25th letter, CECo submitted NSD-TAP-3069, "Braidwood 1: Tec_nical Support for Cycle 5 S/G Interim Plugging Criteria, Pre-WCAP Release," dated April 21, 1994, and committed to forwarding to the Nuclear Regulatory Commission (NRC) the finalized version of that Pre-WCAP. Attached you will find WCAP-14046, a summary in part of the updates to the Pre-WCAP is as follows:

- a section was added summarizing acceptability of the use of the TRANFLO code including consideration of prior NRC
- clarification and editorial changes to outlier data evaluation
- modification to Steam Line Break leak rate methodology
- description of the rotating pancake coil sampling plan for intersections with dents or residual signals was added
- clarification made to Braidwood-1 IPC description to resolve review comments

It is CECo's understanding that review of WCAP-14046, will disposition outstanding technical issues related to IPC for Braidwood Unit 1, in particular resolution of the leakage portion. If the Staff has any additional questions, we request that they be expeditiously communicated to CECo.

The affidavit sets forth the basis on which the information may be withheld from public disclosure by the Commission and addresses with specificity the considerations listed in paragraph (b)(4) of Section 2.790 of the Commission's regulations. Accordingly, it is respectfully requested that the information which is proprietary to Westinghouse be withheld from public disclosure in accordance with 10 CFR Section 2.790 of the Commission's regulations.
