#### LACROSSE BOILING WATER REACTOR

#### AMENDMENT TO PROVISIONAL OPERATING LICENSE

Amendment No. 30 License No. DPR-45

- The Nuclear Regulatory Commission (the Commission) has found that:
  - A. The filing\* by Dairyland Power Cooperative (the licensee) dated August 17, 1979, as revised January 15, May 1 and July 6, 1981, complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations set forth in 10 CFR Chapter I;
  - B. The facility will operate in conformity with the filing, the provisions of the Act, and the rules and regulations of the Commission;
  - C. There is reasonable assurance (i) that the activities authorized by this amendment can be conducted without endangering the health and safety of the public, and (ii) that such activities will be conducted in compliance with the Commission's regulations;
  - D. The issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public; and
  - E. The issuance of this amendment is in accordance with 10 CFR Part 51 of the Commission's regulations and all applicable requirements have been satisfied.

- 2. Accordingly, Provisional Operating License No. DPR-45 is hereby amended by renumbering Paragraph 2.C(4) (fire protection) to 2.C(6) and adding a new paragraph 2.C(5) to read as follows:
  - (5) The licensee shall follow all provisions of the Commissionapproved Guard Training and Qualification Plan, including amendments and changes made pursuant to 10 CFR 50.54(p). The approved Guard Training and Qualification Plan identified as "LaCrosse Boiling Water Reactor Guard Training and Qualification Plan," dated August 17, 1979, as revised January 15, May 1 and July 6, 1981, consists of Safeguards Information which is being protected from unauthorized disclosure pursuant to 10 CFR 73.21. The Guard Training and Qualification Plan shall be fully implemented in accordance with 10 CFR 73.55(b)(4) and Appendix B to 10 CFR 73 within 60 days of this approval by the Commission.
- 3. This license amendment is effective as of its date of issuance.

## LACROSSE BOILING WATER REACTOR SPER REVISION

Revision to First Paragraph of Section 2.2.

### 2.2 Training

The training program and critical security tasks and duties for the security organization personnel is defined in the LaCrosse Boiling Water Reactor Guard Training and Qualification Plan which meets the requirements of 10 CFR Part 73, Appendix B for the training, equipping and requalification of the security organization members. The training program provides a commitment to preclude the assignment of any member of the security organization to a duty prior to his being trained, equipped and qualified to perform the assigned duty in accordance with the approved guard training and qualification plan.
