This is in response to your letter of April 15, 1994, in which you describe actions that the Duke Power Company is taking to address the concerns described in our March 17, 1994, Systematic Assessment of Licensee Performance (SALP) report for the McGuire station. Our SALP report specifically requested you to address the weaknesses identified in the functional area of maintenance.

We have reviewed your response and note that you have identified two key areas for increased management attention: 1) human performance improvement, and 2) equipment reliability improvement. You have assigned the Station Manager and Engineering Manager to be responsible for corrective actions in these areas. You also provided additional details of these and other related improvement initiatives during a meeting in the NRC's Region II office on May 2, 1994, and stated that you expected to provide a progress report to the NRC in August 1994 with results of these actions.

We will examine the effectiveness of these actions during future inspections.

We appreciate your cooperation in this matter.


