NOTICE OF VIOLATION

Wesleyan University Middletown, Connecticut 06457 Docket No. 030-20108 License No. 06-00483-10

As a result of the inspection conducted on November 14, 1990, and in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions," 10 CFR Part 2, Appendix C (Enforcement Policy) (1990), the following violations were identified:

- A. Condition 18 of License No. 06-00483-10 requires that licensed material be possessed and used in accordance with the statements, representations, and procedures contained in part in a letter dated June 12, 1989.
 - The "Receipt of Radioactive Materials Packa is" Section in the "Wesleyan University Guide to Radiation Safety", included with the June 12, 1989 letter requires that wipe tests to be made of the carton, packing materials, outer container, and vial of all packages containing radioactive material.

Contrary to the above, four packages, which acrived on August 10, 1990, August 17, 1990, August 24, 1990 and August 31, 1990, each containing 500 microcuries of phosphorus-32 we a not wipe tested upon arrival.

This is a Severity Level Iv violation. (Supplement VI)

2. The "Survey Frequency" Section in the "Wesleyan University Guide to Radiation Safety", included with the June 12, 1989 letter requires that the radiation protection staff monitor all areas where radioactive substances are used for contamination on a guarterly basis.

Contrary to the above, the radiation protection staff did not monitor all areas where radioactive substances are used for contamination from September 4, 1989 to May 8, 1990.

This is a Severity Level IV violation. (Supplement VI)

 The "Periodic Surveys of Radiation Areas" Section in the "Wesleyan University Guide to Radiation Safety", included with the June 12, 1989 letter requires that isotope users keep records of radioactive contamination surveys which they perform.
