SUBJECT: COMBINED INSPECTION REPORT NOS. 50-352/94-12 AND 50-353/94-12

This letter transmits the results of the resident safety inspection by Messrs. N. Perry, T. Easlick and Ms. A. Wilford from May 3, through June 6, 1994, at the Limerick Generating Station, Limerick, Pennsylvania. The inspection focused on issues important to ensuring the public health and safety and consisted of observations of activities, reviews of documents and interviews with plant personnel. The results are documented in the enclosed report and were discussed with Mr. R. Boyce of your staff at the conclusion of the inspection.

In general, activities were found to be conducted safely. In one instance, enforcement discretion was exercised because of PECO Energy's comprehensive corrective actions. The event involved a health physics technician's failure to properly enter the projected release time into the dose assessment computer code during a reactor water cleanup (RWCU) resin transfer, as well as the technician's failure to acknowledge that the projected offsite dose was in excess of the Emergency Action Level, for an Unusual Event declaration.

The plant staff's overall response to problems associated with both the RCIC systems was assessed as weak. Operators did not identify a low oil level on the Unit 1 RCIC pump. Furthermore, it took over 2 days for plant personnel to add oil to the Unit 2 RCIC oil pump.
